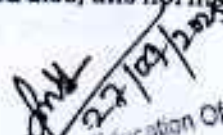

The above sanction is Subject to fulfillment of following conditions:

- (1) The grant for recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
- (2) The School shall abide by the provisions of Right to Children to Free and Compulsory Education Act, 2009 (Annexure - I) and the Right to Children to Free and Compulsory Education Rules, 2011 (Annexure - II).
- (3) The School shall admit in Class I, to the extent of 25% of the strength of that class, children belonging to weaker section and) disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion. Provided further that in case of pre-primary classed also, this norms shall be followed.

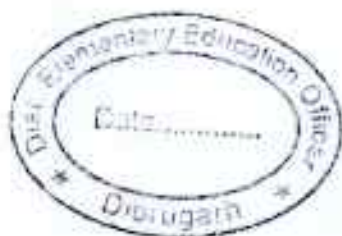
